- Growing trees in 4' and 5' landscape planters is not recommended, as they are prone to tearing up the asphalt. While this concept looks great, it would be best to ensure that what is included in the plan can be delivered, to be fair to the community who will anticipate its development.
- The 10.5' vehicle travel lane is highly commendable by the Committee.
- Traffic calming plans still need to be developed.
- Emergency vehicle routes have not been included in the plan yet.
- Businesses are concerned about how loading and unloading of supplies would work. Overall, more studies need to be done before moving forward with any ideas.

- It was clarified that this neighborhood vision was developed based on the analysis done for the ATP; it is integrated into the overarching plan already.
- About 2000 people from the mailing list alone have been introduced to this project, and the interactive draft plan forum is up and will be online for the next 2 weeks, allowing more people to add comments and suggestions.
- On page 45 of the report, in the Community Vision statement, the phrase, “Consider safety for all modes of travel”, does not convey enough urgency to show that safety is a priority.

Questions:

- What languages were used for translation, in particular for Asian languages?
- Why do we need an environmental document on the plan? Will this delay plan implementation? How were projects scored with respect to accident corridors versus environmental justice communities?
- Did bicycle stores provide feedback?
- Does the plan address the increased amount of work for County staff in order to implement the plan?
- Is there a centralized implementer?

Committee comments on the public draft:

- Right on red removal and slip lane removal are included as infrastructure recommendations. Did that suggestion come from the community and what does the County need to do in order to implement that?
- Response: The community expressed challenges of being able to cross the street safely at intersections. These recommendations were made in an effort to address those concerns.
- Driver awareness needs to be expanded and fleshed out. The current references are inadequate.
- Safe Routes to School programs – Parents need to be taught.
- Safe Neighborhoods need to be promoted, if they are indeed really safe.
- SacDOT needs to commit to sweeping bicycle lanes.
- Development activity and utility activity cause parallel cuts in bike lanes. The patches installed afterwards are not great and result in a safety problem. Need to increase/improve inspection and confirmation that repairs are safe and adequate.
- The designation of study corridor seems like a delay. There should be a Class II bike lane while studying the segment for a Class IV.

Response: Most of the facilities proposed for Class IV are already a Class II.

- Electric transportation, in particular, micromobility, is seriously underrepresented. There is no addressing of the rules and regulations on how to control scooters, etc. Charge points should also be incorporated into the plan.
- Bike lockers listed are only at light rail stations. This makes it seem like no businesses in Sacramento have bike lockers for their employees, which is not the case.
- There needs to be more publicity for the public draft to encourage people to comment. The Transportation management agencies were not aware that we released the public draft.
- Add information on volunteer maintenance programs in regards to implementation and funding to address the rising cost of maintenance.
- There should be more photos of Sacramento region infrastructure and a new cover photo. The public draft is too wordy and there is too much information that is repeated.
- Use the phrase “people who live, work, and play” in Sacramento County, rather than just residents.
- One committee member was not able to edit her own comment or delete her comment.
- Several committee members wanted to see the draft a second time in December.



**Summary:** The Hazel Avenue/US Highway 50 Interchange project includes the creation of a new bicycle/pedestrian route along Hazel Avenue that is separated from vehicular traffic between Folsom Boulevard and the American River Bicycle Trail. The new 12-foot-wide facility would run along the east side of Hazel Avenue beginning South of Folsom Avenue, at the proposed intersection Hazel Avenue and the future Atlanta Street (referred to as the “jughandle” due to its shape from an aerial perspective). It would extend to the north and cross the proposed US 50 eastbound on-ramp at grade, and then continue along the east side of the Hazel Avenue overcrossing to cross US 50. The trail would then extend adjacent to the loop on-ramp and be grade-separated at the US 50 westbound ramp terminal. The bike path would cross underneath the US 50 ramps with concrete slab bridge structures.

Planning-efforts related to this project include:

- Sacramento Area Council of Governments (SACOG) Blueprint and Regional Transportation Plan
- Affordable Housing Plan for Easton Place and Glenborough at Easton (Easton Place Project).

**Funding Source(s):** Transportation Development Fee Program, Measure A Sales Tax, and developer fees.

**Background Information:** The project is located at the existing Hazel Avenue/US 50 interchange within Sacramento County and the City of Rancho Cordova. The project area is bounded along Hazel Avenue by the Tributary Point/westbound off-ramp intersection to the north, and extends approximately 1,000 feet south of Folsom Boulevard to a future intersection within the Easton Place development (Attachment 1). The project limits along US 50 begin approximately 3,200 feet west of the existing Hazel Avenue Overcrossing and extend 2,500 feet east of the Natoma Overhead (post miles 15.0 to 17.2). Improvements along Folsom Boulevard would extend from approximately 1,200 feet west of the Hazel Avenue intersection to 900 feet east of the intersection.


The proposed project is needed for the following reasons.

- Existing and forecasted traffic operations and congestion are below acceptable operating standards at the Hazel Avenue/US 50 interchange.
- Planned and approved developments identified by the adopted Sacramento County General Plan and the Sacramento Area Council of Governments’ Regional Transportation Plan, including the

increased traffic volumes associated with the proposed Easton Place Project, will increase the traffic volumes at the Hazel Avenue/US 50 interchange beyond acceptable operating standards.

- Implementation of mitigation identified in the Easton Project Final Environmental Impact Report (EIR) (County of Sacramento 2008) is required in order to accommodate the increased traffic volumes associated with that development. The Easton Project mitigation includes reconstruction of the Hazel Avenue/US 50 interchange as well as grade separation of Hazel Avenue over Folsom Boulevard and the light rail tracks. The Easton Project will contribute its fair share of funding to the improvements.

Project design is underway. Construction is scheduled for Summer 2025.

**4. Capital Corridor SouthEast Connector**

**Review and Comment**

- The consultant clarified that the full length of the connector is not included in the plans. (i.e. 14 miles of the middle segment) The agreement with SACOG was to place priority on the end segments—Folsom and Elk Grove. Currently, they are working with SACOG to get the remaining portions included.
- The northeast side of the connector does not appear to be as finished as the southwest side.

- For now, no advanced planting along the future bike path is taking place. However, the County has been consulted on different plants to use, and a landscape master plan is being developed. Additionally, the City of Folsom is resistant to any landscaping around White Rock, due to a lack of irrigation system. It will be looked into whether establishments might provide access to their water supply.
- Committee suggestion: SacDOT's Landscape Architects should invest in perennial grasses instead of ornamental landscapes/plants, to lessen the maintenance required for medians. (e.g. oak trees should be avoided since they require more irrigation)
- The Committee wanted to know if there is any way they could help with acquiring funds, and with assuring that the future bike paths will run through disadvantaged communities. The consultant shared that they will be applying for grants totaling \$8 million. Once the entire trail along D3 segment connecting to El Dorado County is completed, they will look into building additional paths to increase accessibility.

- There is an advertising campaign gap in educating drivers about bicycle and scooter movement, and zero emission goals. Various platforms are underutilized, such as social media, the local news, and especially signage placed at intersections, which is relatively cheap and doable.
- Grant applications are focused on raising driver awareness around schools. Suggestion: Can those kinds of driver awareness signs and messaging rotate around the County with pop-up alert campaigns?
- Suggestion: Look into the Caltrans workers safety campaign and see construction worker accidents by automobile, to determine how effective that campaign was.

**Motion:** Suggest to the Board of Supervisors the following five critical needs for the County's FY 2022-23 budget in priority order:

1. Increased funding for bicycle and pedestrian infrastructure per the Active Transportation Plan (expected adoption in 2022)
2. Increased funding for maintenance of bicycle infrastructure, including street sweeping and illegal camp removal
3. Enhancement and replacement of warning indicators of the presence of cyclists to drivers, such as delineators, green paint, striping, signage, and lighting
4. Non-infrastructure bicycle and pedestrian programs, including:
  - driver awareness campaigns (e.g. Caltrans's "My dad works here" billboards to raise driver awareness to avoid construction sites on the highway and reduce worker fatalities),
  - bicycle traffic school (e.g. At Santa Cruz Bicycle Traffic School, bicyclists that are given tickets for traffic violations have the option of attending a class on how to safely use a bicycle in traffic in lieu of paying the moving violation fine.)
  - open streets events
5. Increase DOT staff by 1.0 FTE dedicated to bicycle planning and implementation in order to increase external grant funding for bikeway infrastructure and programming and to implement non-infrastructure programs.
