Project Description

The County of Sacramento Department of Transportation (SACDOT) is in the preliminary design phase of the Waterman Road at Central California Traction Company (CCTC) Railroad Crossing Project. You are receiving this newsletter because you are a resident or property owner whose property is located within or near the project limits. The project is on Waterman Road, from Thimbleberry Drive to Ribera Street. We are holding a public meeting to solicit community input on the proposed roadway improvements and to provide residents with an opportunity to learn more about the project, ask questions and express any concerns they may have.

Background Information

The Waterman Road at CCTC Railroad Crossing Project includes the construction of a new at grade crossing on Waterman Road at the existing CCTC Railroad Crossing. The project will also include the construction of approximately 800 feet of new curb, gutter and sidewalk and installation of Class 2 bike lanes. Every effort will be taken to minimize impacts to existing fences and landscaping on adjacent properties.

The estimated construction cost for the project is \$2,766,00. All project costs will be funded by the Financing District North Vineyard Station (NVS).

The project will improve neighborhood connectivity, circulation, relieve congestion, and increase safety for all modes.
